Course Regulations:

- Each player must register, have a set of clubs and play only one ball.
- More than five players in one group is not allowed.
- If holding up play, allow following players to go through.
- Please replace divots, repair ball marks and rake traps.
- An adult must accompany children under 13 years old when playing.
- Carts: Must be a licensed driver to operate golf cart. All carts must remain on paths around tees and greens.
- Destruction of, damage to, or defacing state property (golf course, carts, etc.) is a misdemeanor and violations will be handled according to state law.
- No outside food or beverages are allowed.
- Shorts must be worn at all times.

Local Rules:

- USGA Rules govern all play.
- Stakes, all fences bordering the course, the maintenance area, and safety fences are out of bounds.

Pace Of Play Tips:

- Play a realistic cut of tees for your ability.
- Keep pace with the group in front of you.
- Keep search for lost balls to a minimum.
- Take two or three clubs to next shot.
- When approaching green, leave equipment on shortest route to next tee.
- Look over your putt while others are putting.
- Be ready to putt when it's your turn.
- Leave green immediately and mark your score on the next tee.
